## 1. Réamhrá

### *Introduction*

Comhlíonann an Polasaí Iontrála seo ceanglais an Acharta Oideachais 1998, an Acharta Oideachais (Iontráil i Scoileanna) 2018 agus an Acharta um Stádas Comhionann 2000. Agus an polasaí seo á dhréachtú, chuaigh bord bainistíochta na scoile i gcomhairle le foireann na scoile, le pátrún na scoile agus le tuismitheoirí leanaí atá ag freastal ar an scoil.

*This Admission Policy complies with the requirements of the Education Act 1998, the Education (Admission to Schools) Act 2018 and the Equal Status Act 2000. In drafting this policy, the board of management of the school has consulted with school staff, the school patron and with parents of children attending the school.*

Tá na dátaí agus na hamlínte ábhartha do pholasaí iontrála Gaelscoil na Camóige leagtha amach san fhógra maidir le hiontráil bhliantúil na scoile a fhoilsítear go bliantúil ar shuíomh gréasáin na scoile seachtain amháin ar a laghad roimh thús an phróisis iontrála don scoilbhliain lena mbaineann.

### **2. Spiorad sainiúil agus cuspóirí ginearálta na scoile.** *Characteristic spirit and general objectives of the school.*

Is bunscoil Chaitliceach í Gaelscoil na Camóige ina chuirtear fáilte roimh gach páiste cuma cén cúnla teanga, sóisialta nó creidimh atá acu, cuma cén náisiúntacht iad nó cén riachtanas speisialta oideachais nó míchumas fisiciúil atá orthu. Bunaíodh Gaelscoil na Camóige le freastal a dhéanamh ar thuismitheoirí an cheantair a bhí ag éileamh bunoideachais Lán-Ghaeilge dá bpáistí.

*Gaelscoil na Camóige is a Catholic primary school where all children irrespective of linguistic, social, religious background; nationality, special educational need or physical disability, are welcome. Gaelscoil na Camóige was founded to serve parents in the area who wished their children to be educated through the medium of Irish.*

Aithnítear cearta tuismitheoirí a bpáistí a chlárú in a rogha scoile, ach tá Bord Bainistíochta Gaelscoil na Camóige freagrach freisin as cearta phobal na scoile trí chéile, agus go háirithe cearta pháistí na scoile atá cláraithe cheana féin. Éilíonn sé seo breith chóir chothrom faoi réir ag prionsabail an dlí nádúrtha ag cur leas na bpáistí ar fad san áireamh. Ag tacú leis an scoil i gcúinsí den chineál seo, tá sé de cheart ag an mBord Bainistíochta uasmhéid líon na bpáistí in aon rang ar leith a leagan síos.

Cuirtear leas an pháiste aonair chun tosaigh i gcónaí agus is i gcuideachta a thuismitheoirí a thugaimid faoina oiliúint agus faoina oideachas. Díritear ar na buanna atá ag an bpáiste a fhorbairt chomh fada agus is féidir.

*The individual child's well-being always takes precedence and school and parents work hand in hand to educate the child. Every effort is made to develop the child's talents as far as possible.*

*Emphasis is placed on continuous, worthwhile work. We undertake to teach the child good social skills, a high moral standard, a wide range of academic and practical skills and pastimes. And all of those through the medium of the Irish language.*

## Polasaí Iontrála Gaelscoil na Camóige

Déantar iarracht cumas labhartha agus scríofa na teanga Gaeilge a thabhairt don pháiste go nádúrtha ionas go mbeidh sé/sí ábalta é/i féin agus gach is spéis leis/léi a chur in iúl go héifeachtach.

*We endeavour to give the child a natural facility in both spoken and written Gaeilge so that he/she can effectively express himself/herself and all that interests him/her.*

Ar ghlagadh áite dá bpáiste sa scoil, iarrtar ar thuismitheoirí geallúint a shíniú go dtacóidh siad leis an scoil Riail na Gaeilge agus an Cód Iompair a chur i bhfeidhm.  
*By accepting a place for their child in the school, parents are requested to sign an agreement to support the school in implementing Riail na Gaeilge and the Code of Behaviour.*

Comhoibreoidh Gaelscoil na Camóige leis an gComhairle Náisiúnta um Oideachas Speisialta i gcomhlíonadh feidhmeanna na Comhairle faoin Acht um Oideachas do Dhaoine a bhfuil Riachtanais Speisialta Oideachais Acu 2004 maidir le soláthar oideachais do leanaí a bhfuil riachtanais speisialta oideachais acu, lena n-áirítear soláthar agus feidhmiú rang nó ranganna speisialta nuair a iarrann an Chomhairle a leithéid.

*Children with special needs enrolling in Gaelscoil na Camóige will be provided with resources in accordance with the level of resources provided by the Department of Education and Skills*

Féadfaidh an Bord Bainistíochta cóip de thuairisc leighis agus / nó uairisc shíceolaíochta an pháiste a iarraidh nó féadfaidh sé iarratas a dhéanamh go ndéanfaí measúnú ar an bpáiste láithreach a bheadh ina chabhair don scoil riachtanais oideachais an pháiste agus na seirbhísí tacaíochta a bheadh de dhíth a mheas. Déanfaidh an Bord Bainistíochta a dhícheall na hacmhainní agus tacaíochtaí a bheith i bhfeidhm sula bhfreastalóidh an páiste ar an scoil. Áirítear leis seo, múinteoir oideachais speisialta, cúntoíri riachtanais speisialta etc; saintrealamh nó troscán speisialta, seirbhísí taistil etc.

*The Board of Management may request a copy of the child's medical and/or psychological report or may request that the child be assessed immediately in order to assist the school in establishing the educational needs of the child and to profile the support services required. The Board of Management will endeavour to have all resources and support in place before the child is admitted to the school. This may include the special education teacher, special needs assistants etc, specialised equipment or furniture, transport services etc.*

Tionólfar cruinniú le húdaráis na scoile agus tuismitheoirí an pháiste a bhfuil riachtanais speisialta aige nó aici agus pléifear oriúnaíocht na scoile don pháiste. . D'fhéadfadh cáschruinniú a eagrú ina bhfreastalódh tuismitheoirí, múinteoir ranga, múinteoir oideachais speisialta, síceolaí, nó oibrithe sóisialta de réir mar is cuí.

*The school authorities will meet with the parents of the special needs child to discuss the school's suitability for the child. If necessary a full case conference may be called including parents, class teacher, special education teacher, resource teacher and psychologist or social workers as appropriate.*

*Appeals under Section 29 of the Education Act 1998 will be considered and determined by an independent appeals committee appointed by the Minister for Education and Skills.*
